Please read the following information carefully. This form outlines all fees and the due dates.

Welcome to Carla's Dance Factory! We are excited that you want to become a company member. Please read the following paragraphs carefully. All fees and due dates are listed below. Please initial each paragraph indicating that you understand all fees and due dates.

Tuition: At the time of registration, parents are expected to pay a registration fee of \$15.00 and the first month's tuition. Monthly payments are due the first week of each month. We do not pre-bill. A \$10.00 late fee is charged to your account if payment is not received by the 20th of the month. Returned checks are charged a \$25.00 returned check charge. Please note that tuition is not based on the number of classes each month, but is calculated as a yearly fee divided into ten payments for the dance school term. We do not pro rate tuition. Refunds are not issued for absences.

Company Class Costumes All classes except Senior I: At registration Company classes will make 3 deposits of \$75.00. You may post date 3 separate checks as follows. September 1<sup>st</sup>, October 1<sup>st</sup>, and November 1<sup>st</sup>. If you do not want to post date checks you may pay your \$225.00 deposit in full. The balance of the costumes is due January 5<sup>th</sup>.

Senior I Company costume and competition fees: Members of Senior I will make a \$125.00 separate payment on the 15<sup>th</sup> of the month for August, September, October, November and December. Costume balances will be due the first week of Jan. Competition fee balances will be due March 1<sup>st</sup>.

Company Fees

Company classes must pay a company fee of \$75.00. This fee is due at the time your child auditions and must be paid before your child may audition.

Recital Fees: A \$50.00 recital fee is charged to each student participating in the recital. Families with more that one member enrolled will be charged \$75.00 for the family. The recital fee is charged to eliminate charging admission at the door. The recital fee pays for the auditorium rental, custodian/clean up fees, maintenance engineer, set design, extra draperies, sound system rental, sound engineer, sound track production, trophies and certificates. Recital fees are due February 1<sup>st</sup>.

Past Due Accounts: Any student with an account balance over 60 days will be suspended and will not be allowed to return to class until the account is brought current. A late fee of \$10.00 will be charged any outstanding fees not paid by the due date. This includes company fees, costume and competition fees.

**AGREEMENT:**

Carla's Dance Factory will provide dance lessons to Dance Student for a fee upon the conditions of this Student Agreement.

**FEE:**

The fees for dance lessons are payable in nonrefundable monthly installments. Fees are due and payable in advance to Carla's Dance Factory on or before the first day of each month (August – May) a registration fee of \$15.00 must accompany the initial tuition payment. A \$10.00 late fee will be charged for all payments not received before the 20<sup>th</sup>. of each month. If DANCE STUDENT attends any lesson during a particular month, then the entire monthly installment is due and payable. The fees for dance lessons are as follows.

DANCE STUDENT (and her/his legal guardian if DANCE STUDENT is under the age of 18) releases, agrees to indemnify, agrees to hold harmless and agrees to defend Carla's Dance Factory, Carla Gillespie Berry and Landlord, from all loss, personal injury damage, claim, liability of expense to DANCE STUDENT, DANCE STUDENT'S family, guest and visitors occurring on the premises of Carla's Dance Factory or on the way to, at or on the way from any function of Carla's Dance Factory whether or not caused by the negligence of Carla's Dance Factory, her helpers, agents or employees.
